8. To provide guidance and strategic leadership for achievement of targets set under Balochistan Education Sector Plan.
9. To coordinate the inter-ministerial roles and other Donors/NGOs for effective collaboration and synergies.

The Secondary Education Department through PPIU will coordinate the entire BESP.


